Mares must be specifically booked by name. Booking is valid only to mare and owner names and may not be transferred without the express consent of Walnut Hall Ltd. In the event the booking is purchased by two or more individuals or entities, each individual or entity shall be jointly and severally obligated under this Agreement. The mare shall be made available for breeding through the end of the breeding season or until earlier pronounced in foal, unless the mare or stallion dies or becomes unfit to breed or unless the mare is excused in writing by Walnut Hall Ltd.

If any charges due and owing in a given month are not paid on or before the first day of the succeeding month, the owner hereby authorizes Walnut Hall Ltd. to add to said owner's account a credit service charge of 1 1/2% per month. In addition, should Walnut Hall Ltd. refer such outstanding account to an attorney or collection agency for collection, the owner herein consents to pay an attorney's fee or collection agency fee of 30% of the amount then owing on the account. Further, Walnut Hall Ltd. shall have a security interest in the born or unborn foal and the mating certificate to secure payment of any obligation to Walnut Hall Ltd., whether arising under this Agreement or otherwise. The owner further grants Walnut Hall Ltd. and its authorized representatives a power of attorney to execute documents necessary to perfect and enforce such security interest, including the filing of financing statements. This Agreement and the application or construction thereof, shall be governed exclusively by its terms and by the laws of the Commonwealth of Kentucky, and the owner(s) agrees to submit to the jurisdiction and venue of the courts of the Commonwealth of Kentucky.

Service fees are due and payable when the mare has a live foal, or changes ownership whichever comes first. In the event that the mare is sold, no refund of the service fee shall be due. All board accounts must be settled before the mare is removed from the farm. Walnut Hall Ltd. reserves the right to demand payment of stallion service fees before the mare is removed from the farm if the board bill is delinquent, and to apply all payments to board accounts until such accounts are paid in full. If the mare fails to produce a live foal, and the mare has not been sold, the fee will be refunded provided a written claim, accompanied by a certificate from a qualified veterinarian stating that the mare has been subject to an acceptable vaccination program during pregnancy for equine rhinopneumonitis and the return of the mating certificate, is presented within thirty days after the mare was due to foal or the date that the mare slips or gives birth to a dead foal. A live foal is hereby defined to be a foal that is able to stand up and nurse.

Walnut Hall Ltd. reserves the right to test visiting mares for infection at the expense of the owner. No barren mare, maiden mare or mare that foals under suspicious circumstances will be bred to any of our stallions without first having passed these tests. Walnut Hall Ltd. reserves the right to reject any mare deemed physically unfit for breeding before or after such treatment.

Neither Walnut Hall Ltd. nor its directors, agents or employees, shall be liable for any injury, disability or death suffered by any horse, from any cause whatsoever, while in the custody of Walnut Hall Ltd., and the undersigned owner specifically assents to such condition, and waives any and all claims for damage resulting from any such injury, disability or death.

All mares must be standard and registered with the U. S. T. A. No blind mares accepted. All mares entering Walnut Hall Ltd. must be accompanied by or have sent in advance a negative Coggins test taken within 6 months. The undersigned owner hereby agrees to all of the terms and conditions specified above and represents that all information regarding the mare contained herein is true and accurate.

Persons acting as agents must file notarized letters of authorization from the owners stating the agent is acting on their behalf and that said owner will be responsible for all expenses incurred. Failure to comply with this condition will impose personal and financial liability upon such agent with respect to all matters in connection with or arising out of this booking contract.
